Mr. Geraldsen spoke of their work detail and the work that had been done on the collection system. There was discussion regarding the building at the Leachate facility.

Mr. Geraldsen also went over several items regarding work that was being done around the sewer plant.

Old Business

Chickens and Livestock in the Hamlet – The Town Board felt that this topic had been covered with the public hearing and moved on to new business.

New Business

VFW Boulevard of Honor for Coeymans Hollow – VFW Post Commander Jeffrey LaQuire stood and spoke about the Boulevard of Honor in Ravena and the interest from the community in expanding it out to Coeymans Hollow. They would like to go from Gedney Hill to Chimney Top, approximately 59 poles. If there is anyone interested they can contact him. They would also be placing banners on Church St. and Pulver Ave. to the VFW. Commander LaQuire spoke of finding out information on Civil War soldiers that had ties to our community and if there are no pictures he has Civil War silhouettes that could be used in their place. There was also discussion about how the program works. Supervisor McHugh was going to reach out to get permission to use the poles in the Hollow.

Water & Sewer Expansion — Supervisor McHugh stated that he has spoken to the Village attorney about expanding the water and sewer district across the bridge and up to the Port of Coeymans, the Industrial Park and the JAT property. He stated that the Industrial Park already has sewer and water. The Port has water but not sewer.

Restricted Thruway Exit – Supervisor McHugh stated that he and the grant writer had been working on this and had met with Sam Parker at the State about getting a restricted thruway exit, both north and south bound, north of the industrial park.

Ms. D'Ambrosio, the Town Grant Writer, spoke of the process she had gone through in finding out who to contact regarding this.

Supervisor McHugh stated that timing is everything and the state is looking at this in terms of the offshore wind project that is going to be happening.
