Supervisor McHugh opened the meeting and led the Pledge of Allegiance. He stated that all Board members were present except Councilmember LeFevre.

Presentation

RCS Football Team – Supervisor McHugh and the Board members presented the RCS Football Team and coaches with letters from Congressman Tonko, Sheriff Apple, a proclamation from State Senator Hinchey and a plaque from the Town Board in honor of their season winning the Class B regional championship.

Public Announcements

COVID-19 – Supervisor McHugh gave an update on the current numbers for the County. He stated that the County is providing masks and at home test kits for local municipalities to distribute. He stated that he and Councilmember Baker would be there the following day from 8-10 am to distribute them.

Town Hall Closed on December 24th & 31st - Supervisor McHugh stated that Town Hall would be closed on December 24th and 31st for the Holidays.

Town Clerk Report – November 2021 Report read by Town Clerk Rowzee

Motion to Accept Report

Supervisor McHugh made a motion to accept the report as read, seconded by Councilmember Collins. APPROVED – VOTE – AYES 4 – NAYS 0 – ABSENT 1 – SO MOVED

Town Clerk Rowzee stated that it had been a pleasure to serve the residents of the Town of Coeymans. She thanked her Deputy Bonnie Keyer for her hard work. She stated she had left the office in better shape than she had inherited it in. They had gone through hundreds of boxes of records, disposed of over 250 boxes of obsolete records, organized and scanned a majority of the remaining records and the office. She stated that they had cut costs and with the efficiencies put in place needed fewer staff than before to run the office. She stated that it had been very rewarding work and she was glad to have the opportunity.

Police Department Report – November 2021 Report read by Chief Keyer

Chief Keyer stated that they had submitted the Federal Railroad Administration grant application. He stated that they had assisted the Coeymans Hollow Fire Department with their parade.

Councilmember Baker asked Chief Keyer to have the officers hold the truck traffic accountable during the increased traffic of salt retrieval season.

Building Department Report – November 2021 Report read by Jason Chmielewski

Supervisor McHugh made a motion to table the November 2021 sewer report until the following month, seconded by Councilmember Baker.

Old Business

Park Improvements Update – Supervisor McHugh stated that the basket poles were in and corrected to the 10 foot height. He stated the work was not completed in time for Copeland to complete the coating on the court and so this and the striping would be done in the spring. He stated that the playground equipment was still in construction and would hopefully be here by the end of the month. It would then be installed in early spring. He stated that the construction documents were almost ready to put the Riverfront project out to bid to start work in the spring. He stated that the bathroom facilities for the parks were moving ahead and would be bid out separately from the grant project.

Street Lights on 144 – Councilmember Collins asked for an update on the streetlights for Route 144 in North Coeymans where the side streets intersect. Supervisor McHugh stated that he has requested quotes from Central Hudson for lights the same as those throughout the rest of the Town but has not received it yet.

Broadband Update – Councilmember Collins also asked for an update on the broadband internet quotes. Supervisor McHugh stated that he and Mr. Evans from Statetel had the quotes and the he would sit down with him on January 4th to go over it.

New Business

NYS EFC Engineering Planning Grant – Supervisor McHugh read a letter from NYS EFC stating that the Town of Coeymans had been selected for up to \$24,000 in funding for an Inflow & Infiltration and Sewer Extension Study Project. He stated that this would be the first step and then there would be other grants to apply for after this study is completed. He stated that he has a meeting on January 4th to speak with MJ Engineering about this.

Valley Paper Mill Grant – Supervisor McHugh stated that the town did not receive the grant for the Valley Paper Mill at Chimney Top Park. It was extremely competitive this year and they had known that going in, but it was still worth trying for.

Tractor RFP – Supervisor McHugh stated that he had met with Scott Searles regarding the need for a new front end loader. He stated that they had sold the one that was kept at the salt shed earlier this year as it was costing more money to maintain than it was worth. He stated that they need to put an RFP to put the purchase of a new one out to bid.

2022 Organizational Meeting – Supervisor McHugh stated that it would be held January 1st with the swearing in at 9am and the meeting to follow. He made the following motion:

The Town reserves the right to waive any informalities in the bid and to reject, in whole or in part, any or all bids.

He stated that they had considered appointing her the previous year when they appointed Councilmember Bruno and it had been a hard decision. He gave a short history of her life here in Coeymans.
