The Coeymans Landing site already has existing utility services that will be extended to the new building. The Joralemon Park site has an existing septic system and well previously permitted and constructed and will be utilized as part of the new building. The total ground disturbance associated with both projects is less than one (1) acre; and

WHEREAS, the Town's engineering consultant M.J. Engineering and Land Surveying, P.C. has prepared plans and specifications for the project that are ready to advertise for public bidding; and

WHEREAS, the Town Board of the Town of Coeymans intends to construct public restrooms at Coeymans Landing and Joralemon Park. Each restroom will be approximately 543 square feet in size and will not be a conditioned space. The Coeymans Landing site already has existing utility services that will be extended to the new building. The Joralemon Park site has an existing septic system and well previously permitted and constructed and will be utilized as part of the new building. The total ground disturbance associated with both projects is less than one (1) acre; and

WHEREAS, pursuant to the State Environmental Quality Review Act (SEQRA), 6 NYCRR Part 617.6(a), an agency proposing to undertake an action must determine whether the action is subject to the requirements of SEQRA; and

WHEREAS, under SEQRA 6 NYCRR Part 617.5(b)(9) the construction or expansion of a primary or accessory/appurtenant, non-residential structure or facility involving less than 4,000 square feet of gross floor area and not involving a change in zoning or a use variance and consistent with local land use controls is a Type II action that is not subject to review under SEQRA.

NOW, THEREFORE BE IT RESOLVED, that the Town Board of the Town of Coeymans hereby determines that the project to construct public restrooms at Coeymans Landing and Joralemon Park constitutes a Type II action pursuant to the State Environmental Quality Review Act, 6 NYCRR Part 617, and, therefore, no additional environmental review is required.
