Town Clerk Millious continued by distributing the Tentative Budget to the Town Board.

Councilwoman Rogers asked Supervisor Traver if the tax rate was going up, down or staying the same.

Councilman Boehm inquired as to if there are any highlights or anything that the Board needs to know.

Supervisor Traver stated that they came up with a new formula working on the Sewer Budget, which shows more details between the Joint Town and Village appropriations and expenditures.

Councilman Touchette stated that in previous years the Supervisor had used this as an opportunity to make a presentation about the budget and talk about the rational behind the budget with the appropriations and revenues. He continued by asking if Supervisor Traver wished to say anything about that.

Supervisor Traver stated that he would have to look at the worksheets again and reiterated that he believes that it is by department and Sue King the Human Resource clerk did most of the benefit package on it.

Councilman Boehm stated that there is a variance column and continued by asking if it was new.

Supervisor Traver stated that it is and added that it shows the difference from the previous year and added that another big change is that it shows the department request and his Tentative Budget figure.

Councilman Boehm inquired as to if the tax rate will be flat with no increase or decrease.

Supervisor Traver stated that was correct.

Councilman Touchette stated that he appreciates the Tentative Budget and he looks forward to reviewing it and continued by asking Supervisor Traver if he had any further comments.

Supervisor Traver stated that he didn't.

Councilman Boehm stated that normally they set up a series of Workshops with the department heads to go over the budget.

Supervisor Traver stated that they will not be doing that at this meeting and added that on at Tuesday's meeting they will be setting up some dates for the Workshops with department heads.

Councilman Touchette inquired as to if the department heads will receive the Tentative Budget in the morning.

Town Clerk Millious stated that she takes care of that and it will be first thing in the morning as well as there being copies for the public.
