Attorney for the Town Pastore stated that he doesn't know if it is necessarily prohibited and added that it is usually most are separate because there are separate issues involved and it's not something that he would be opposed to and then asked what their practice has been.

Councilman Dolan stated that since he has been here, this has been the practice.

Supervisor Crandall interjected that it has been for the past 30 years.

Councilman Langdon asked if there ever could be a situation where the Town Board and Zoning Board would need separate counsel.

Attorney for the Town Pastore stated that he knows that certain towns will have a Town Attorney and then a couple or several assistant Town Attorneys and usually they have separate counsel for the Planning and Zoning Boards or there may be one Attorney for both those Boards. He added that it is not prohibited to the best of his knowledge that you have the Attorney for the Town also handle the Planning and/or Zoning Board matters. He concluded by saying if their customary practice has been that they have a separate Attorney, they should go ahead with it but it is something the Attorney for the Town could handle as well, there is nothing that prohibits the Attorney for the Town handling Zoning and/or Planning matters or legal issues and it varies from town to town.

Supervisor Crandall stated that this is something that they can revisit but suggested for now that they pass the resolution as is, have discussion later and see it they can save the Town some money.

Councilman Youmans interjected that he isn't sure if the Attorney for the Town would want to take on all the extra duties.

Councilman Dolan stated that Attorney Pastore does have experience with Planning.

Supervisor Crandall interjected that the Attorney for the Town fee is the same that it has been for the past 2 years.
