New Business

Ravena Housing Assessment – Attorney to the Town Pastore informed the town that he and the assessor were both recommending that the Town Board accept an offer from Ravena Housing in a tax tertiary matter. The current offer was an assessment of \$240,000 with a 7% cap rate.

Supervisor Crandall mentioned that there were other places such as Albany Water Board and Albany City were also looking for a reduction in their assessments this year. Attorney to the Town Pastore stated that this is not out of the ordinary.

Motion to Accept Assessment Offer

Councilman Dolan made a motion to accept the settlement of a \$240,000 assessment on the Ravena Housing property (Louis Apartments) with a 7% cap rate, seconded by Councilman Baker.

Small Truck for Highway – Superintendent Searles stated that included in this year's budget for the Highway Department had been \$40,000 to purchase a small truck. His contact to purchase off of state contract has provided him with a price of \$33,940. Councilman Youmans and Councilman Baker inquired if this truck would be the right vehicle for the needs of the Highway Department. Superintendent Searles stated that this would become his truck which would leave his current vehicle available for plowing and sanding. This new truck would meet his needs.

Motion to Authorize Superintendent

Councilman Youmans made a motion to authorize Superintendent Searles to purchase a Ford F-150, seconded by Councilman Dolan.

Discussion – Councilman Dolan wondered if a minimum bid should be added to the notice. John Cashin stated that the property alone was worth \$11,500 and he estimated that it would cost \$3,000 to dispose of the mobile home. It was suggested that a minimum bid of \$8,500 be placed in the notice.

Councilman Youmans suggested we send this to the adjoining property owners. Attorney to the Town Pastore suggested that the notice be mailed to all property owners within 100ft. of the property to give them the opportunity to purchase said property.

John Cashin stated that the lot was large enough for building if a variance was obtained.
