## 1. Local projects

- a. BH reported the Coeymans incineration local law has not been passed yet.
  - i. Lafarge has a permit to burn tires and there is a question on whether the incineration law would conflict with the permit and make the Town subject to potential litigation.
- b. The Army Corps of Engineers is putting out expanding Tappenzee Bridge piers/trestles as permanent. Comment deadline is January 4.
- c. MM Port of Coeymans would like to extend a building near Yanni's Too restaurant. The Restaurant will move to the new location and expects to then be open year round. The Planning Board is reviewing the site plan.

- d. MM Planning Board is reviewing plans to establish a 9 acre solar farm near the Coeymans Hollow Firehouse. NYSERDA recently created a new model law per IH.
- e. SL noted recommendations of using brown fields as potential sites for solar farms rather than using viable farmland.
- f. SL recommended residents consider section 93 of town code-Flood prevention plan.
- g. SL will meet with the library director December 17 to partner in spearheading a junior naturalist club.
- h. SL Randy Walker is working on community air screening samples.

# 2. NRI Updates

- a. On January 29 5-7:30 pm at Colonie Library will be a Capital District Regional Planning Commission CAC Round Table focusing on NRIs, green structure code
- b. Ingrid Haeckel has edited some of the the submitted NRI materials.
  - i. She will update the bedrock geology map, number 7 and others as needed.
  - ii. She is supporting our efforts to create a draft NRI the holidays so that the CAC can work on finalizing the materials beginning in January. We would also like a considerations black included with each map that leads readers to see the applicability of the information.
- c. Haeckel advised creating a checklist for the planning Board to assist in reviewing sites.
  - i. This would provide accurate useful resources in chunks that are easy to absorb.
- d. SL recommended CAC member Please read through the NRI draft and add input.
- e. Next step will be create an event to share the draft with the public in a friendly way like an open house.
